After discussion and looking at the response from Carmarthenshire County Council Highways department, the committee were in agreement with the County Council in that the site is unsuitable due to restricted visibility and could pose a risk to road users and as such unanimously recommended REFUSAL.

Comments from the Coal Authority was noted by members in that the site raises "Fundamental Concerns" and as such, the applicant needs to submit a Coal Mining Risk Assessment, or an equivalent report, to support the new build dwelling element of the planning application. To date, no relevant information has been submitted. Members also raised concerns regarding the fact that some of the works had already started and the application was partly retrospective. It was also felt that insufficient information was provided as to what would be the purpose of the storage facilities and whether or not it would have a detrimental effect on what is fundamentally a rural area. The committee unanimously recommended REFUSAL			
PL/02390	10/08/2021	Caravan Melden Stables, Pembrey, Llanelli, Burry Port, SA16 0JS	Creation of one additional family traveller pitch with one residential static unit, touring caravan, utility/day room (disabled friendly) using approved agricultural access (S/33780)
Members discussed the application and raised concerns that the applicant was already in breach of planning permission granted on S/33780. Meetings have taken place between local residents and both Town & County Councillors where it has been apparent that the applicant has breached a number of the conditions attached to their previous application. It appears that the applicant is flagrantly flouting the law with no concern as to the detriment to the local area. Councillors also raise concerns as to the legality of the application as there seems to be a dispute as to whether the applicant actually owns all of the land in question. Due to a number of concerns, members felt that they could not support the application and unanimously recommended REFUSAL Members RESOLVED unanimously to request the Town Clerk send a letter to the County Council raising awareness of the non-planning related concerns noted during the meeting.
